Booking Terms and Conditions

Seo Teirmean is Cumhachan Òganan Dhùn Èideann Ltd a thaobh chlàraidhean:

These are the Terms and Conditions governing bookings with Òganan Dhùn Èideann Ltd:

Dearbhadh mu Àite

Gheibh sibh dearbhadh sgrìobhte gum faigh ur pàiste àite. Na lùib, bidh fiosrachadh air seiseanan ur pàiste agus an dèit a thòisicheas iad.

Confirmation of Place

Your child's place will be confirmed in writing. This confirmation will include details of your child's allocated sessions and commencement date.

Sgrìobhainnean Poileasaidh

Bidh Òganan Dhùn Èideann a' cumail gu dlùth ri sreath iomlan de phoileasaichean is mhodhan-obrach. Thathar ag iarraidh air pàrantan is air luchd-cùraim an leughadh mus tig ur pàiste thugainn.

Policy Documents

Òganan Dhùn Èideann has a comprehensive set of policies and procedures to which we adhere. Parents/carers are requested to read these prior to your child's attendance.

Fàirdeil agus Pàigheadh

Thèid fàirdeil a chur thugaibh san Ògmhios agus a-rithist san t-Samhain. Gabhaidh an dìoghladh mìos air mhìos. Nochdaidh sùim a' chuibhrinn agus dèit a' pàighidh air an fhàirdeal. Bidh an cuibhreann ri lìbhrigeadh an 20mh de gach mìos roimhe, ge b' e a th' ann an dòigh-dhìoghlaidh. Mar eisimpleir, feumaidh cìsean na Dùbhlachd an dìoghladh ron 20mh den t-Samhain.

Invoicing and Payment

Invoices are issued in June and again in November and can be paid in monthly instalments. The instalment amount and due dates are detailed on the invoice. The monthly sum due is payable in advance by the 20th day of each month whatever payment method is used. For example, fees for December must be paid by the 20 November.

*It is preferred that payments are made by **bank transfer** and our bank details will be clearly stated on the invoice. All invoices will be sent out by email to the email address provided, but we will send out a paper copy on request. An annual administration fee of £15 per family is applicable and will be included with the first invoice and annually thereafter.*

Gabhaidh pàigheadh leis na dòighean a leanas cuideachd:

Eàrlas cùram-cloinne

Seic: air a sgrìobhadh do dh' "Òganan Dhùn Èideann" gu Cunntasan, 2 Cnoc a' Chamaidh, Dùn Èideann, EH4 8EY. Nach dèan sibh cinnteach gun tèid ainm ur pàiste agus àireamh an fhàirdeil a sgrìobhadh air cùl na seice. Bidh £35 ri phàigheadh air seic nach gabh iomlaid.

Airgead ullamh: faodaidh pàigheadh do bhall den sgioba agus gheibh sibh cuidhteas air a shon.

Bidh beachdachadh ann air ìre nam prìsean aig toiseach gach bliadhna-sgoile. Thèid rabhadh a dhèanamh do chomhairle nam pàrant agus do phàrantan air atharrachadh sam bith dà mhios ro-làimh sa char as giorra. Bidh cead aig Òganan Dhùn Èideann ri cìs a bharrachd de 5% iarraidh airson pàigheadh anmoch. Ma bhios dìth-phàigheadh ann fad greis, leanaidh sinn na modhan-obrach sa phoileasaidh dìth-phàigheadh againn.

Payment can also be made using the following methods:

Child-care voucher

Cheque: to Òganan Dhùn Èideann, Accounts, 2 Cammo Hill, Edinburgh, EH4 8EY. Payable to "Òganan Dhùn Èideann". Please ensure your child's name and the invoice number are stated on the reverse of the cheque. Returned cheques will incur a charge of £35.

Cash: payment can be handed to an Òganan member of staff and a receipt will be provided.

Fees are reviewed at the start of each academic year. The parent council and parents will be given not less than two months notice of any changes. Òganan Dhùn Èideann reserves the right to charge a late payment fee of an additional 5%. If persistent non payment continues, we will follow procedures outlined in our non-payment policy.

Attendance and Absence

All children should attend regularly at the sessions booked. Notice should be given in advance for holidays, appointments, etc. and as soon as possible in the case of illness. Fees will be charged at the full rate for any periods of holiday or sickness.

Cancellation or Changes

All cancellations to your reservation or a reduction in the number of sessions must be made in writing to the Wraparound Manager. A minimum of four weeks' notice is required. A request for a change of session may also require this notice period, but we will try and
